ONTPR 2011 by Vicki Johnson scribe for event: Very pleased with site and turn out everything for the event went smoothly everyone pleased. Campers at event ran an auction for Ceaserer's Creek Pioneer Village for updates to their site this started a discussion on is this allowed. Point of order called by Jerry H. that it should be discussed if desired during the meeting.

ONTPR 2012 by Dan D.: Segundo for event: Booshway Dan'l Cain Dates are July 6 -14 2012 Site is in Canton, OH. Site is starting to be prepped. There are still a few obstacles to overcome Rita is familiar with most of these. Dates are slightly different but we've gotten some pretty good feedback on them. We are expecting a good turnout. All Contracts and bids are in except one and should be in by end of next week.

ONTPR 2013 by Jerry H: Dates are June 21-29 2013 Booshway is Karen Ball; Site is Ceaserer's Creek Pioneer Village. We will hear more about this as it draws closer.

Mid-West 2011 by Rita L. was Held in southern IL. It was hot and small. Believed to break even site was great but needs to be held sometime other than August.

NEPR 2012 Delegate in Charge Jeff H.: No site at moment has offer from IMM of PA in Emmelton, PA Jeff proposes using this site. Need board approval to move to PA. Discussion moved to another part of meeting. Possibly Old business but not for sure.

EPR 2011 by Jerry H. Delegate in Charge: Do not be surprised if this event loses money. When problems come up we have to take care of them (referring to mud). The staff has done a great job with the weather they've had. Staff is working on making sure people can get out.

EPR 2012 by Ruth P. Delegate in Charge: Site is Troy, OH Dates are September 21 – 29 2012 Budget is in and being adjusted. Fliers are out and approved. Site is having work parties.

SEPR2011 by Wade R. Booshway: Everything is going great bridges being built to ranges and everything should be ready for this event.

SEPR 2012: Currently no staff or sight. Please ask around. Sites are easy to come by staff is the problem.

## Blizard update by Jerry H.:

Jerry went to preliminary hearing in WV if he had not been there the case would have been thrown out due to the 6<sup>th</sup> amendment (right to face your accuser). Ms. Blizard's attorney at that point waived the preliminary hearing. Case is now being held over to a grand jury hearing. Should be heard the 2<sup>nd</sup> week of September 2011 but may not have been unable to reach a DA for conformation. If it was not heard the DA's office has 3 times to put it before the Grand Jury. Will continued to keep the board updated as info becomes available.

# Taxes by Jerry H:

Received letter about a year ago from IRS due to taxes not being filed since 2007 they pulled our 501c3 tax status. At that time the board approved hiring of an accounting firm all available info sent to them by Rita L. and Jerry H. Accounting firm told Jerry H. we may have dodged bullet due to the Law changes from the IRS

there were roughly 255,000 groups lost their 501c3. Accountant said if we file 2010 and forward taxes pay an \$800.00 fee to IRS for reinstatement we can continue to operate as a nonprofit group. This should also cover us in the interim we should be okay according to the Accountant unless the IRS for some reason doesn't approve our reinstatement. Jerry will continue to update the board

#### **Gate Hours**

Were changed during a phone conference. To 3-6pm for any vehicular traffic, after early setup. This is creating a lot of problems. This should be looked at during New Business. Rita L. says this will not work from her perspective as a gate captain.

Motion by Wade R.: To establish guide lines on service animals.

Dan D. asked about the fact of this being old business. Was told no cause it has been discussed before.

Discussion on Legitimacy of service animal

Dan D. says service animals should be leashed and vested with markings

Jerry H says according ADA we can't keep them out or we open ourselves to lawsuits. The only thing we are allowed to ask about the service animals is what service they perform. If a legitimate service animal becomes a nuisance we can then ask them to leave.

Wade R. then says we should adopt ADA rules governing service animals.

Motion: by Wade R. to adopt ADA rules governing service animals as our guidelines

Discussion by Wade R. this opens a big can of worms after reading ADA rules we are basically powerless. On proving a service animal is an actual service animal.

Jillian says we need to certify these animals somehow.

Wade reads from ADA rules on their web site: We basically can do nothing about them we must allow them.

Discussion: John A. according to the current rules staff only has the right to the edge of a person's camp without the legal authorities and a search warrant.

Jerry H. All state and federal laws apply to us at camp and camper's camps are considered private property.

Rita L. What are the Staff members allowed to do? What if the Staff member violates private property laws? What do we do to that person?

Jerry H. Says we can't do anything without the offended person coming up to us as board and asking us to bring this staff member up on ethics charges.

Jillian M. Asks what if a camper steals from a trader. How do they initiate steps to handle theft? Start with the Booshway and go forward.

Jerry H. To revise booshway books to reflect changes so staff knows they aren't above State and Federal Laws and are not to consider themselves a police force.

John A. I will take the responsibility to write artillery rules using NMLRA and other sources as a guide

**Quartermaster Duties** 

Jerry H.: JD and Randy approached Jerry about changing the way the Quartermasters duties are done.

Proposal from JD

All Foundation equipment is to be stored in a central location in this case Southern VA. As quartermaster all equipment will be stored in a large box trailer owned by the quartermasters there will be a lease charge paid to them for the trailer. They will deliver all equipment to every event and make sure that it can be set up, there will be a charge for delivering the equipment to the event to come out the event budget roughly \$1.00 -\$1.10 a mile. They will be on sight only to make repairs as needed not to set up equipment. The equipment will be standardized all poles made to the same length. All equipment would be stored in the trailer so every event would have access all foundation equipment. As well as changing all water buffalos to standard (SAE) buffalos so that they can be maintained with parts from any hardware store in the country. Also buying or making a kit of Dog Soldier and First Aide responders bags with Radios batteries and other important information in them, also the foundation would then supply at a cheaper cost than events can buy batteries and radio. Also a continuing updating and replacing equipment as needed. JD is supposed to make a written proposal before the next foundation meeting via phone. This will be a non paid position; they will do the duties of quartermaster for free.

Motion by Dan D.: For JD to put proposal together & become quartermaster for maintaining all foundation equipment.

Jillian M. suggest we change wording to less than a year out after closing of the event

Wade: where did this rule come from? He has never seen this rule before or heard of it. Can't find where or when this came into effect

Bev: When she started putting new books together she found stuff missing and stuff put in that had never been there before, but was in the meeting minutes.

Discussion: Dan D. The Mid-west has used this area a lot more in the last ten years than the ONWTPR

Handicapped people setting up camp during the extreme heat camp took longer than the rules allowed; camper said it took them 2 - 3 hours. Gate people said don't push to get setup done due heat.

John A. Also said that it took almost 6 hours for them to unload, he tried to apologize latter in the week and believed the problem had been settled. He believes that rules should be enforced.

The boards belief on this matter is John A. Should in the future act more calm and offer to help instead of just trying to enforce the rules.

When you get new pages take old ones out and destroy them and put new pages in proper place.


# Garbage Runs
